QUOTA EXCHANGE

The market-clearing price established for the July, 2011 Quota Exchange was \$30,000.00.

The next Quota Exchange will be held on August 15, 2011. All offers to sell and bids to purchase quota through the Quota Exchange must be received at the SaskMilk office by midnight, August 6, 2011. SaskMilk recommends that offers and bids be submitted well in advance of the deadline date to ensure adequate time for corrections, if necessary.

Just a reminder to producers that when making bids on the Quota Exchange, the price on offers to sell quota is the minimum price that the producer is prepared to accept for that quota. Only if the market-clearing price is equal to or greater than the producer's minimum price will that producer qualify for participation in the Exchange. Conversely, the price on offers to purchase quota is the maximum price that the producer is prepared to pay for that quota. Only if the market-clearing price is equal to or less than the producer's maximum price will that producer qualify for participation in the Exchange. The clearing price is set at the price where the smallest difference exists between the accumulated volume offered for sale and the accumulated volume bid to purchase.

The results of the Quota Exchange are outlined in the following Table.



FORM DEADLINES TO BE STRICTLY ENFORCED

Producers, please be reminded of the following deadlines for submitting forms to the Board office. All forms must be 100% complete to be considered. <u>These deadlines will be strictly enforced by the</u> **Board, no exceptions.**

When mailing, faxing or emailing forms to the Board, producers should call the Board office to ensure that their forms have been received prior to the deadline.

1. Private Quota Transfers – forms due by 11:59p.m. on the 6th day of each month for an effective date of the 1st day of the following month. This deadline also applies to farm name changes and moving to new production facilities.

2. Quota Exchange Bids – forms due by 11:59p.m. on the 6^{th} day of each month for an effective date of the 1^{st} day of the following month

3. Transfer Credits – forms due by 11:59p.m. on the 20th day of each month for an effective date of the 1st day of the same month

4. Banking Information Changes – **Producers changing bank account information must notify the Board of this change at least 7 days prior to the next producer payment date.**

In June, Saskatchewan had a monthly CDC allocation of **725,664 kilograms** of butterfat. In the month of June, Saskatchewan production was **-2,605 kilograms** of butterfat **under** and cumulatively **under** by **-170,850 kilograms** of butterfat. On a percentage basis, Saskatchewan is at **-1.93%** within our CDC allocation flexibility limits based on the Continuous Quota model. The -1.50% lower limit is in effect.

THE STEEP LEARNING CURVE FOR A NEW BOARD MEMBER By: Sheldon Peifer

When I first became a Board Member, the only thing that I brought to the table was my own experience as a dairy and grain farmer. I am now beginning to understand some of the reasons things are done in a certain way, the time it takes for those decisions to come to finalization and even though I may not have thought so at the beginning, the Milk Marketing Board has not only my best interest on the table, but also the interest of the entire provinces.

As a new Board Member as of last November, I believed that when I entered into this position my involvement would be more with the day to day things that happen at the Milk Marketing Board. Exactly the opposite happens at our monthly meetings. Some of the many things that we look at include marketing, western milk pooling and policies. These discussions are sometimes five to ten years away from implementation. There are policies and decisions coming in our direction that we must prepare for so we as a province can make sound decisions for our provincial industry or at the very least have some good judgement in the direction we need to go. Some of these things, such as sharing production blips with western partners and transportation issues that are so very different between provincial borders and the distance within Saskatchewan with the large pickups that are getting larger by the month. Looking at the impact of having only one milk plant in our province when some provinces have several and how over time this may change for our province. The vast resources in Saskatchewan are just starting to be utilized to some of their potential as we move from an agricultural based economy to one that is a world-wide resource-based economy.

Something that I became aware of shortly after being elected to the Board was that there is a lot of time spent on the computer reading and trying to keep on top of all the information being sent to us. I have come to appreciate the fact that our meetings are the length they are so we can be as well informed as possible before a decision is put forth. I have learned to appreciate our longer term Board Members, both past and present, for the enormous number of hours they have dedicated to Board meetings, meeting with provincial representation, conferences and staying on top of changes in not only our province and within Canada. I have also learned how very important it is for us to have a provincial board. There are a very diverse group of individuals on this Board with a very diverse personality base, but I believe we work well together with a common goal in mind, that being, keeping our milk producers on even ground with other milk producers across this country.

GST ON JUNE, 2011 PRODUCER STATEMENT

SaskMilk requested a GST ruling from Canada Revenue Agency in September, 2010 on the SMMB promotion/administration levy. <u>The ruling was requested when SMMB moved from</u> <u>a government Crown Agency to a Marketing Board.</u> SaskMilk received the ruling earlier this month indicating that GST is required to be applied on the SMMB promotion/administration levy effective the June, 2011 month-end payment. Producers must ensure they include this GST payment on GST remittance forms in the future.

DECREASE IN PRICE FOR JUNE, 2011

Producers will notice a decrease in June prices from May, 2011. The billing to the processor was approximately 1.6 million dollars less in June from May. This was due to Canadian Dairy Commission permits for Skim Milk powder being filled in June. This is normal at this time of the year as the CDC purchases the last of 2010/2011 requirements. SaskMilk anticipates pricing to return to more traditional levels next month.

FREQUENTLY ASKED QUESTIONS

What is the maximum amount of transfer credits that I can transfer out in a month?

The maximum transfer credits a producer can transfer out in a month are equal to what the producer's cumulative under position was in the previous month. You can only transfer out to a cumulative position of zero credits.

What is the maximum amount of transfer credits that I can transfer in?

There is no limit to the amount of credits that can be transferred in within a rolling 12 month period. The only limit when transferring in credits would be to not drop below the -30 credit day limit (-20 credit days effective the end of November) at the end of each month or you will have lost the opportunity to carry-forward those credits to produce that milk in the future.
