IMPORTANT REMINDER -DESIGNATED REPRESENTATIVE FORM

This is a reminder to licensed producers to please complete the Designated Representative Form which was included with the December, 2010 newsletter. It is important that the form is completed and returned to the Board by fax or mail immediately.

These forms are required for your protection to ensure that only authorized individuals act on your behalf. This includes the authority to transfer credits and to make bids on the quota exchange. Also, only those persons authorized to vote on behalf of a licensed producer at producer meetings will have their votes recognized. Make sure that your vote counts by returning this form.

If you have misplaced your form, please contact the Board office. Those producers that have not returned their forms will be directly contacted by Board staff and asked to return their forms as quickly as possible.

CHAIRMAN'S MESSAGE – BLAINE McLEOD

The recent events unfolding in the Middle East have again brought into focus the importance of a secure and stable food supply. One of the root causes of the political instability has been the short supply and the high cost of food. The Tunisian fruit and vegetable salesman, Mohamed Bouazizi, was simply trying to earn a living and was denied that right because he would not pay the bribes to continue to be involved in the marketplace. He was pushed to the point that he thought his only option was an act of protest in which he set himself on fire by dousing his body with gasoline. His eventual death has sparked a revolt that ultimately brought about the downfall of the Tunisian government and that spirit of revolution has spread to many neighboring states. The ability to feed and care for your family and loved ones is something that we take for granted. We should never forget that we are indeed blessed to have the ability to work hard and be fairly rewarded for our labour. Our dairy industry enjoys security and stability and the protection and promotion of our system of supply management is indeed worthwhile.

One of the efforts that we were recently involved in was the annual lobby day that was organized by Dairy Farmers of Canada. It was my privilege to be a part of a team of directors and staff who were able to spend quality time with all but one of our MP's and Senators. Some of the key messages we were able to leave with our elected members is that our industry directly and indirectly sustains 215,000 jobs and contributes \$15.2 billion to our annual GDP. In addition we contribute over \$3 billion in tax revenue on a yearly basis to federal, provincial, and municipal governments. We received assurances that Canada will not trade away our system of supply management and that the interests of Canadian dairy farmers will continue to be defended at the international level. The time and effort spent in cultivating a relationship with our elected leaders is a significant investment but is well worth it. When we speak as one voice our message is heard and has been shown to be very effective. I recently read a quote from Theodore Roosevelt that summarizes quite well the lifestyle that we enjoy as Canadian dairy farmers. He said "No man needs sympathy because he has to work, because he has a burden to carry. Far and away the best prize that life offers is the chance to work hard at work worth doing."

I look forward to meeting with you at our spring producer meetings and want to encourage your attendance and involvement. As usual we have some important issues to discuss and we need to hear from the membership. Please make the days of April 4, 5, and 6 a priority and attend a meeting that is close to you. Further details are included in the newsletter.

FORM DEADLINES TO BE STRICTLY ENFORCED

Producers, please be reminded of the following deadlines for submitting forms to the Board office. All forms must be 100% complete to be considered. **These deadlines will be strictly enforced by the Board, no exceptions.**

When mailing, faxing or emailing forms to the Board, producers should call the Board office to ensure that their forms have been received prior to the deadline.

- 1. Private Quota Transfers – forms due by 11:59p.m. on the 6th day of each month for an effective date of the 1st day of the following month. This deadline also applies to farm name changes and moving to new production facilities.**
- 2. Quota Exchange Bids – forms due by 11:59p.m. on the 6th day of each month for an effective date of the 1st day of the following month**
- 3. Transfer Credits – forms due by 11:59p.m. on the 20th day of each month for an effective date of the 1st day of the same month**
- 4. Banking Information Changes – Producers changing bank account information must notify the Board of this change at least 7 days prior to the next producer payment date.**

QUOTA EXCHANGE

The market-clearing price established for the March, 2011 Quota Exchange was **\$27,000.00**.

The next Quota Exchange will be held on April 15, 2011. All offers to sell and bids to purchase quota through the Quota Exchange must be received at the SMMB office by midnight, April 6, 2011. The SMMB recommends that offers and bids be submitted well in advance of the deadline date to ensure adequate time for corrections, if necessary.

Just a reminder to producers that when making bids on the Quota Exchange, the price on offers to sell quota is the minimum price that the producer is prepared to accept for that quota. Only if the market-clearing price is equal to or greater than the producer's minimum price will that producer qualify for participation in the Exchange. Conversely, the price on offers to purchase quota is the maximum price that the producer is prepared to pay for that quota. Only if the market-clearing price is equal to or less than the producer's maximum price will that producer qualify for participation in the Exchange.

The clearing price is set at the price where the smallest difference exists between the accumulated volume offered for sale and the accumulated volume bid to purchase.

The results of the Quota Exchange are outlined in the following Table.

PRODUCER PRICES FOR FEBRUARY, 2011

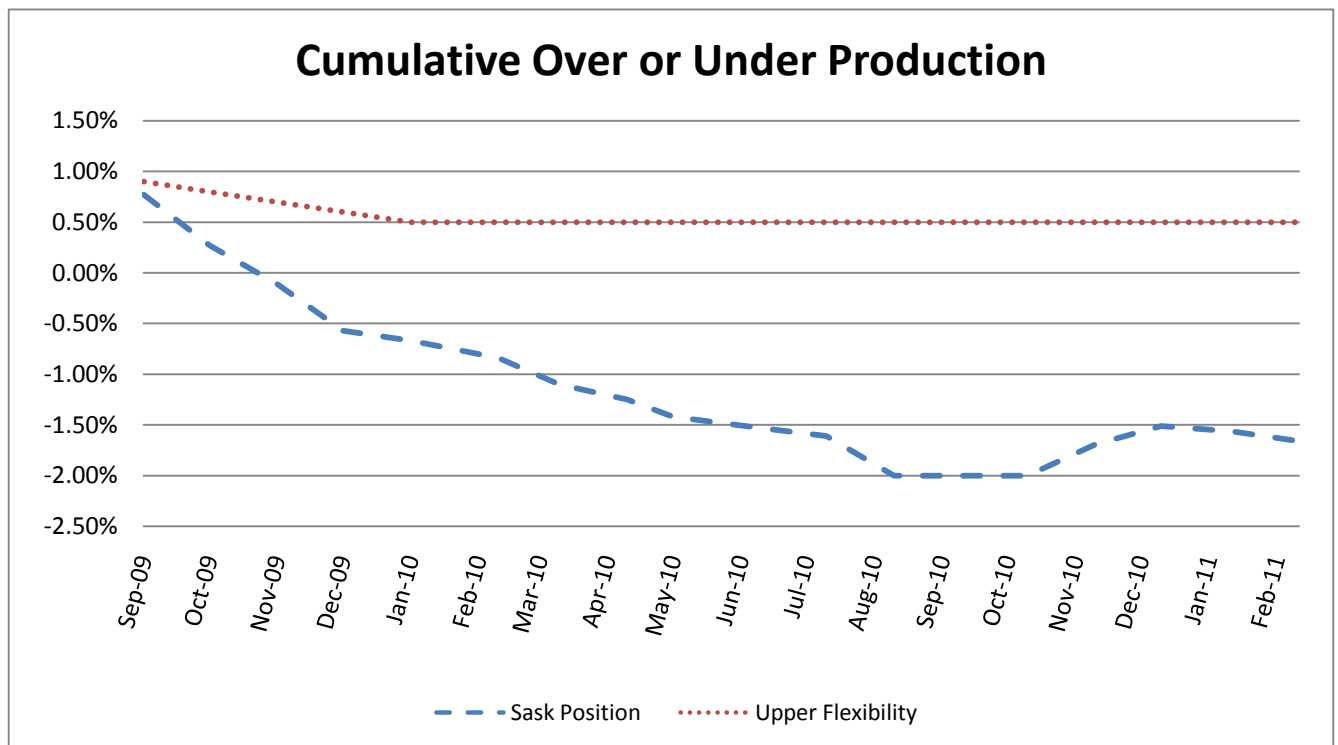
The February, 2011 month-end payment on March 15th to will be the highest component prices the Board has ever paid to producers. There are three main factors for this high component price.

1. \$366,894 was received from the Canadian Dairy Commission (CDC) for January, 2011 pooling results.

2. \$218,701 was received as a one-time payment from the CDC for surplus dollars earned from the sale of Export Butter and Export Skim Milk Powder; and
3. There were no sales of low-priced Special Class products from Saskatchewan.

Next month, the Board will be a contributor into the Special Class Pool for February pooling results. These results will be used to calculate producers' payments for March 2011 production paid April 15th.

Depending on March production from the farm, how the milk is utilized in the plant and dollars contributed in the pool, the March month-end payment will be lower than February. Although it is not possible to predict what the March, 2011 month-end price will be, producers should be aware of this situation and plan cash-flows accordingly.



In February, Saskatchewan had a monthly CDC allocation of **682,398 kilograms** of butterfat. In the month of February, Saskatchewan production was **-9,193 kilograms** of butterfat **under** and cumulatively **under** by **-145,054 kilograms** of butterfat. On a percentage basis, Saskatchewan is at **-1.66%** within our CDC allocation flexibility limits based on the Continuous Quota model. The -1.50% lower limit is in effect.

FREQUENTLY ASKED QUESTIONS

Questions most frequently asked by producers.

What is the maximum amount of transfer credits that I can transfer out in a month?

The maximum transfer credits a producer can transfer out in a month are equal to what the producer’s cumulative under position was in the previous month. You can only transfer out to a cumulative position of zero credits.

What is the maximum amount of transfer credits that I can transfer in?

There is no limit to the amount of credits that can be transferred in within a rolling 12 month period. The only limit when transferring in credits would be to not drop below the -30 credit day limit (**-20 credit days effective the end of November**) at the end of each month or you will have lost the opportunity to carry-forward those credits to produce that milk in the future.

What is the deadline for transfer credits?

The transfer credit deadline for any month is by midnight of the 20th. For example any transfer credit forms in the Board Office on or before midnight of January 20th will be effective January 1st.
