QUOTA EXCHANGE

The market-clearing price established for the May, 2011 Quota Exchange was \$27,499.00.

The next Quota Exchange will be held on June15, 2011. All offers to sell and bids to purchase quota through the Quota Exchange must be received at the SMMB office by midnight, June 6, 2011. The SMMB recommends that offers and bids be submitted well in advance of the deadline date to ensure adequate time for corrections, if necessary.

Just a reminder to producers that when making bids on the Quota Exchange, the price on offers to sell quota is the minimum price that the producer is prepared to accept for that quota. Only if the market-clearing price is equal to or greater than the producer's minimum price will that producer qualify for participation in the Exchange. Conversely, the price on offers to purchase quota is the maximum price that the producer is prepared to pay for that quota. Only if the market-clearing price is equal to or less than the producer's maximum price will that producer qualify for participation in the Exchange. The clearing price is set at the price where the smallest difference exists between the accumulated volume offered for sale and the accumulated volume bid to purchase.

The results of the Quota Exchange are outlined in the following Table.



DIRECTORS' CORNER - JACK FORD

At our recent board meeting, it was decided that each Board member should take turns writing a short article for the newsletter to give the membership a sense of where we are at from several different perspectives.

I will start out by attempting to give all of you an overview of what others in the province are thinking.

Swift Current- most of the producers in attendance at the meeting were most interested in the provincial quota situation. They were quite concerned with the upper flexibility limit that CDC/CMSMC has imposed on the provinces and they felt that an upper limit of +.5% was far too restrictive (the Warman meeting and the Fort Qu'Appelle meeting shared these thoughts). The one strong message that was delivered was that in the event of a possible penalty, cut quota, do not take away flexibility.

<u>Warman</u>- the members in this meeting were also very interested in the flexibility question. The overall reaction was to maintain +10,-20 days. Some people asked about "floating" the 30 day flexibility in relation to where the province is at. It was agreed that this is something to look at. One producer asked about "capping" quota value. This question was met with strong resistance. This question and the same response also came up in Fort Qu'Appelle. There was concern that the COP is not keeping up with our actual costs.

<u>Fort Qu'Appelle</u>- this meeting shared the same views as the two previous meetings except it was much more focused on CQM. Producers wanted to know how we were making out with our WMP partners when talking about bonus add-ons. The only thing we could say is that we are working on it. It was pointed out that CQM is voluntary and to go mandatory would require a producer vote. People were also asking about a new entrant policy. It was pointed out that a New Entrant program was part of our "plan" when forming a marketing board and that the government has given us 18 months to respond. This means we need to have something to take to the members by the fall meetings.

I have been involved with the research file for seven years now and as I pointed out at the spring meetings, with the federal and provincial government involvement along with the very large special donor, **the project has been deemed fully funded by the university!** The final design should be completed very soon and the project should go to tender by late July/early August for a completion date of May 2012. We have received very positive support for the project from SaskCanola and now SaskFlax. Both groups are most interested in the gallery and public education aspect.

PRODUCER SURVEY SUMMARY

At the latest round of producer meetings producers were given the opportunity to respond to the following question:

Should the Board explore a mandatory Board controlled credit transfer system with a set price? Yes No

Results of the survey are summarized below.

Total Surveys: 105

Yes: 65 or 61.9%

No: 37 or 35.2%

Undecided: 3 or 2.9%

The Board has decided that the survey results did not indicate an overwhelming desire to change the transfer credit policy at this time; however they will continue to monitor the situation and consider options that may improve the credit transfer system.

In April, Saskatchewan had a monthly CDC allocation of **737,561 kilograms** of butterfat. In the month of April, Saskatchewan production was **-14,422 kilograms** of butterfat **under** and cumulatively **under** by **-167,923 kilograms** of butterfat. On a percentage basis, Saskatchewan is at **-1.91%** within our CDC allocation flexibility limits based on the Continuous Quota model. The -1.50% lower limit is in effect.

FORM DEADLINES TO BE STRICTLY ENFORCED

Producers, please be reminded of the following deadlines for submitting forms to the Board office. All forms must be 100% complete to be considered. These deadlines will be strictly enforced by the Board, no exceptions.

When mailing, faxing or emailing forms to the Board, producers should call the Board office to ensure that their forms have been received prior to the deadline.

- 1. Private Quota Transfers forms due by 11:59p.m. on the 6th day of each month for an effective date of the 1st day of the following month. This deadline also applies to farm name changes and moving to new production facilities.
- 2. Quota Exchange Bids forms due by 11:59p.m. on the 6th day of each month for an effective date of the 1st day of the following month
- 3. Transfer Credits forms due by 11:59p.m. on the 20th day of each month for an effective date of the 1st day of the same month
- 4. Banking Information Changes Producers changing bank account information must notify the Board of this change at least 7 days prior to the next producer payment date.

FREQUENTLY ASKED QUESTIONS

Questions most frequently asked by producers.

What is the maximum amount of transfer credits that I can transfer out in a month?

The maximum transfer credits a producer can transfer out in a month are equal to what the producer's cumulative under position was in the previous month. You can only transfer out to a cumulative position of zero credits.

What is the maximum amount of transfer credits that I can transfer in?

There is no limit to the amount of credits that can be transferred in within a rolling 12 month period. The only limit when transferring in credits would be to not drop below the -30 credit day limit (-20 credit days effective the end of November) at the end of each month or you will have lost the opportunity to carry-forward those credits to produce that milk in the future.
