# NOTICE TO LICENSED MILK PRODUCERS

# **Permanent Quota Increase**

SaskMilk is issuing a 0.75% permanent quota increase effective January 1, 2012 due to a quota increase issued by the Canadian Dairy Commission and anticipated growth in the market. Producers should make plans to fill this additional quota allocation when it is issued.

# GST ARREARAGE LINE ON PRODUCER STATEMENT

To be compliant with the GST ruling from the Canada Revenue Agency which requires SaskMilk to collect GST on haulage and the promotion levy, SaskMilk must collect the GST from producers dating back to October 1, 2010.

SaskMilk will be recouping GST arrearage in three equal monthly payments. For the next three months (October, November & December) producers will notice a line on their producer statement called GST Arrearage. The GST arrearage is being collected on haulage from October, 2010 to June, 2011 and SMMB Promotion/Admin levy from December, 2010 to May, 2011. October and November GST was deducted as those funds were remitted to Dairy Farmers of Saskatchewan and producers were charged the GST at that time.

Producers will be able to recoup the GST arrearage when filing their GST remittances.

# **DIRECTOR REPORT - FACS - DAVID ENTZ**

Becoming SaskMilk's representative on the Farm Animal Council of Saskatchewan (FACS) board, has opened my eyes to the vital role of FACS. As the provincial producer-driven non-profit organization advancing responsible animal care, FACS educates both consumers and those working in the agriculture industry.

FACS activities range from participating in AgExperience, which taught more than 850 Grade 4 students, their teachers and parent chaperones at Prairieland Park during three days in October, to organizing the Stockperson's School, which will focus on sharing information related to cattle in 2012. In addition, FACS's interactive educational puppet show 'Where'd that come from?' ensures school children around the province know food comes from farms operated by caring producers, not the fridge.

I'm especially impressed with the 'We Care' billboard campaign. This year, images of Saskatchewan producers and ranchers dedicated to maintaining healthy, productive livestock and poultry farms reached even more people driving provincial roadways. The campaign was longer – from mid-May through November – and featured more billboard locations. These efforts depend on multi-commodity support, and SaskMilk was pleased to participate as a sponsor.

Making consumers aware of producers' commitment to responsible animal care 24/7 has become even more important with growing curiosity regarding food production. When commodities face this challenge and/or pressure from animal rights activists, FACS provides advice and ghost written information.

In 2011, FACS further enhanced its role by joining farm animal councils in Ontario, Alberta and British Columbia to support development of a national strategy to address the move of animal rights activists into Canada from the United States. To foster a collaborative effort, the consultation process involved commodity groups and such major food industry leaders as Tim Hortons, Maple Leaf, XL Foods, Burnbrae Farms and Cargill. An update regarding the resulting strategy will be provided at the FACS Annual General Meeting and 'Fence Lines to Corporate Board Rooms' conference, December 7 and 8, 2011 at the Saskatoon Inn.

I encourage dairy producers to attend both events to develop a greater understanding of FACS role and increase their knowledge of growing consumer interest and possible legislative changes resulting from public pressure. This year's prominent well-informed conference speakers represent: Tim Hortons; Cargill; the Harker Heights Texas Police Department; the California Farm Bureau Federation; and the Ontario Farm Animal Council. # **QUOTA EXCHANGE**

There was no market-clearing price established for the November, 2011 Quota Exchange.

The next Quota Exchange will be held on December 15, 2011. All offers to sell and bids to purchase quota through the Quota Exchange must be received at the SaskMilk office by midnight, December 6, 2011. SaskMilk recommends that offers and bids be submitted well in advance of the deadline date to ensure adequate time for corrections, if necessary.

Just a reminder to producers that when making bids on the Quota Exchange, the price on offers to sell quota is the minimum price that the producer is prepared to accept for that quota. Only if the market-clearing price is equal to or greater than the producer's minimum price will that producer qualify for participation in the Exchange. Conversely, the price on offers to purchase quota is the maximum price that the producer is prepared to pay for that quota. Only if the market-clearing price is equal to or less than the producer's maximum price will that producer qualify for participation in the Exchange. The clearing price is set at the price where the smallest difference exists between the accumulated volume offered for sale and the accumulated volume bid to purchase.



In October, Saskatchewan had a monthly CDC allocation of 774,172 **kilograms** of butterfat. In the month of October, Saskatchewan production was **-11,401 kilograms** of butterfat **under** and cumulatively **under** by **-134,267 kilograms** of butterfat. On a percentage basis, Saskatchewan is at **-1.50%** within our CDC allocation flexibility limits based on the Continuous Quota model. The -1.50% lower flexibility limit is in effect.
