Responding to Supply Management Myths...

With Canadian dairy farmers, yet again, caught in the cross hairs of trade negotiations, it is important to understand how to combat the misinformation that rapidly spreads through the news, radio, and Facebook comment sections. As frustrating as it is, there is value in addressing these topics in an effort to support supply management and the success of Canada's system. We've compiled some of the most common myths surrounding supply management with some rebuttals.

1) "Canadian families pay hundreds of dollars more every year for dairy, eggs, and poultry products"

- Retailers set the retail price for milk, supply management only sets the farmgate price.
- In Canada, retail prices for milk are in line with those in other jurisdictions. In 2014, consumers paid an average of \$1.47/litre from fresh milk in Canada, compared with \$1.83 in New Zealand, \$1.81 in France, \$1.15 in the U.S, \$1.19 in Germany, and \$2.35 in China.
- Milk labelled "rBST-free" in the United States is actually higher per litre than milk in Canada (where all milk is free of rBST free) at \$1.64.
- Additionally, since there are no subsidies, Canadian consumers pay once for their milk at the grocery store.

2) "Supply management doesn't adapt to changes in demand and it discourages innovation and productivity"

- Over the years, Canadian dairy farmers have invested millions into their farms, and into numerous research projects. These investments have contributed to milk yield increases of more than 130% without the use of the growth hormone rBST like in some other jurisdictions, this has outpaced the US (+116%), UK (+91%), NZ (+49%).
- Recently, the Canadian dairy industry released proAction, an on-farm sustainability project focused on further innovation and improvement.

3) "Supply Management prevents competition from foreign imports"

- An estimated 8%-10% of the Canadian dairy market is already open to imports, which does not take into account the additional 1.5-2% of access for European cheese granted in CETA, or the additional 3.25-4% of access granted by the TPP.
- Supply management allows our farmers to receive a fair return from the domestic market and, in order to limit our production to market needs, we need to know the quantity of foreign products being imported so we can plan our production.
- 4) "The export market represents better opportunities for Supply Managed farmers"
 - Dairy is not a major export commodity, only 9% of all global milk production is exported
 - The relatively small global export market is already saturated with established big players from countries such as the U.S and New Zealand who are at a competitive advantage due to lower costs of production and the generous government subsidies they receive
- 5) The market price of quota is a barrier for the growth of farms and for those who might want to become farmers.
 - No matter the sector, starting a business from scratch is extremely difficult for a young person who is not taking over the family business. The profitability and stability of supply-managed sectors are success factors in establishing the next generation.
 - Buying a business in a developed market in any sector comes not only with a cost for the assets, but also for the business's client base, and other factors. Buying quota is buying a share of the market. Most dairy farms are passed down within the family or to a non-relative at a cost, including the right to produce, which will allow the next generation to earn a living and grow their businesses.
 - All provinces have new entrant assistance programs for new dairy farms that involve long-term quota loans or grants.

Reminder!

The deadline date for Quota Transfer, Quota Exchange, and 10% Transfer Limit Exemptions is the 6th of each month

Your Quota Transfer, and 10% Exemption Applications must be received on or before the 6th of the month in order to be effective the 1st of the following month

Quota Exchange forms must be received in the SaskMilk office on or before the 6th of the month for that month's Exchange

Code of Practice 2.2 Nutrition and Feed Management

The nutritional requirements of the cow can be met using a variety of feed components. Cows can be fed a total mixed ration (TMR) or alternatively a component based ration. Correct feed management is necessary to ensure good health and welfare. Cows are motivated to perform the same activity at the same time (e.g., feed, rest, ruminate). Cows also prefer to eat during daylight hours. Increased feeding frequency (at least twice per day) has been found to reduce the amount of total mixed ration (TMR) sorting that occurs and allows subordinate cows to access feed more often.

Feed management programs that consider such behavioral needs are likely to reduce stress and aggressive behaviors within a herd, and have a positive impact on herd health and productivity (27).

Dairy cattle experience a number of transition periods (unweaned to weaned, dry to fresh) that present nutritional challenges for producers to meet. Feeding practices have a major impact on the overall health and welfare of cattle. Cattle that are not fed adequately will be hungry, and are also more likely to have reduced immune function (31).

REQUIREMENTS

Cows must receive a ration that is adequate for maintaining health and vigor.

RECOMMENDED BEST PRACTICES

a. ensure the composition of diets reflects production level, reproductive stage, body size, housing and weather conditions

b. test nutrient content of feed ingredients used

c. ensure all rations have been balanced and that all feed components used in the ration are of good quality and free of spoilage

d. Provide fresh feed to the cow daily when she is in the barn, except when fasting is required for medical reasons

e. minimize factors that create stress or aggressive behaviors within a herd

f. provide adequate linear feed bunk space (e.g., 24in, 60cm, per cow)

- g. keep a consistent feeding schedule
- h. provide adequate bunk access time
- i. ensure continuous access by pushing up feed in the bunk.

QUOTA EXCHANGE

The market-clearing price established for the September 2018 Quota Exchange was \$31,818.00.

The next Quota Exchange will be held on **October 15, 2018**. All offers to sell and bids to purchase quota through the Quota Exchange must be received at the SaskMilk office by midnight, **October 6, 2018**. SaskMilk recommends that offers and bids be submitted well in advance of the deadline date to ensure adequate time for corrections, if necessary.

When making bids on the Quota Exchange, the price on offers to sell quota is the minimum price that the producer is prepared to accept for that quota. Only if the market-clearing price is equal to or greater than the producer's minimum price will that producer qualify for participation in the Exchange. Conversely, the price on offers to purchase quota is the maximum price that the producer is prepared to pay for that quota. Only if the market-clearing price is equal to or less than the producer's maximum price will that producer qualify for participation in the Exchange. The clearing price is set at the price where the smallest difference exists between the accumulated volume offered for sale and the accumulated volume bid to purchase. The results of the Quota Exchange are outlined in the following Table.








SK Milk Production

INHIBITOR TEST STATIONS

SaskMilk has established a number of inhibitor test stations around the province. Producers needing to check their bulk tanks for inhibitors can take a sample to the test station closest to their location.

The test stations have the Charm Trio test strips available for testing. The Charm Trio test is the test that the plant uses. It tests for the following drugs:

HOOF TRIMMING CLINIC AND HOOF HEALTH SEMINAR

Location: Saskatoon Area (Warman) Date: November 6 & 7, 2018 Location: Swift Current Area Date: November 8 & 9, 2018

The Western Canadian Certified Hoof Trimmers Association (WCCHTA) together with Nutrisource Inc. will deliver a 2-day hoof trimming workshop for farmers and farm personnel who are interested in learning how to trim. This will be a theory and practical workshop, where you will learn the basics of functional and corrective hoof trimming (based on 5-Step Dutch method) and get to practice trimming cadaver feet. There will also be a half day seminar on day 2 on how to improve hoof health on farm. The course will run from 8:30 am -4pm daily with the following choice of workshop locations:

Tuesday, November 6 to Wednesday, November 7 in Warman, near Saskatoon (501 Neufeld Street, Bay 1, Warman) from 8:30 am – 4pm daily.

Thursday, November 8 to Friday, November 9 south west of Swift Current from 8:30 am – 4pm daily.

Lunch, snacks and drinks will be provided, as well as all trimming equipment and materials. The cost of the workshop will be \$750 (+GST) per person. There will be 2 certified instructors* and each workshop is open to a maximum of 12 people. 
