Time: 2:30pm – 8:00pm (registration will begin at 2:00)

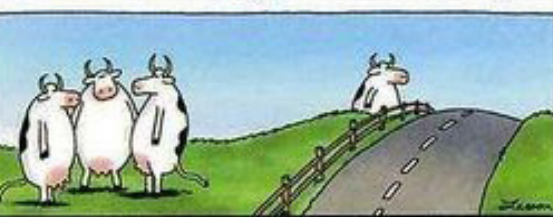
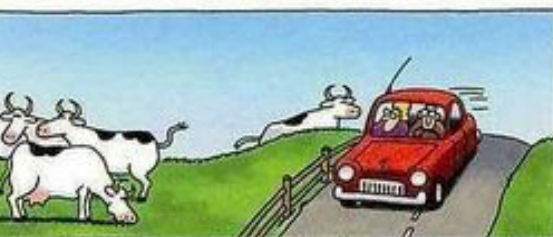

Mental Health Spotlight



Cultivating Gratitude on the Farm

Gratitude can be a powerful tool for resilience in the face of uncertainty and stressful situations. Restrictions, fear, isolation and uncertainty around COVID-19, and weather and economic factors on the farm are some examples that can have a significant strain on our mental health. Meanwhile, the benefits of gratitude can help in those stressful situations and enhance areas of our lives, from our professional and personal relationships, our business, to our sense of fulfillment.

Gratitude can be understood as both a state of being and a personal trait. Ultimately, it's a form of appreciation, whether it's being thankful for a specific situation or a wider life perspective. With gratitude, people acknowledge the goodness in their lives. In the process, people recognize the source of goodness lies at least partially outside themselves. As a result, gratitude also helps people connect to something larger than themselves as individuals – whether to people, nature or a higher power.

Studies have shown that gratitude is strongly and consistently associated with greater happiness. Gratitude can be an effective tool both on and off the farm because it helps us feel more positive emotions, relish good experiences, improve our health, deal with adversity and build stronger relationships.

People feel and express gratitude in many ways. They can apply it to the past (retrieving positive memories and being thankful for past blessings), the present (not taking good fortune for granted), and the future (maintaining a hopeful and optimistic attitude). Regardless of when, where or the current level of someone's gratitude, it's a quality that individuals can successfully cultivate further.

Ways to cultivate gratitude on the farm:

Through acts of kindness: One of agriculture's strengths is sense of community and helping others during hard times. Random acts of kindness can be small and may only take a moment. For example, an illness or death strikes a family during harvest, a convoy of neighbours and their combines will help get the crop off. Or if fire strikes and burns down a barn, community members will donate supplies, their labour and time and help to rebuild.

By showing gratitude to others: Showing gratitude can provide a boost to your mental health. Saying 'thank you' to employees and teammates can inspire them to do the same for someone else. Expressing gratitude to friends and family can often feel more difficult to do. Rather than a simple 'thank you,' you can tell someone you are grateful for them doing something specific and what that means to you. This helps you be grateful for what they have done and also the person themselves, growing your sense of gratitude.

By showing gratitude to yourself: Thinking of and sharing positive traits that make yourself unique and special, whether it's your personality, qualities, your actions can lead to positive self-talk and an increased self-esteem.

By counting your blessings: Pick a time every week to sit down and write about your blessings, which can be done at home, in the office or even in the cab of a tractor, and reflect on what you are grateful for. As you write, be specific and think about what you felt when something good happened to you.

Through meditation or mindfulness: Meditation involves focusing on the present moment without judgement. Although people often focus on a word or phrase (such as peace or 'I am..., I feel..., I see...'), you can also focus on what you're grateful for (the warmth of the sun, the drizzle of rain, the breeze, a pleasant sound, etc.).

By turning negatives into positives: One way to practice gratitude is by changing our perspective, or to try to see things through a different lens. It isn't a cure for negative emotions but helps us be honest with our feelings and what we are going through. Asking yourself questions like:

- o Is there a silver lining to this?
- o Is there a different way to look at this?
- o What can I or have I learned through this?
- o What can I be thankful for in this situation?

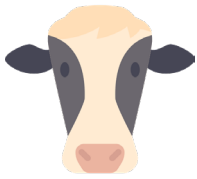
These questions can help turn the negative into a positive and help us through stressful situations.

It's not easy to practice gratitude when you don't feel like it, and it's perfectly normal that you don't feel over-the-moon blessed when you're going through hard times. But you can be sad and disappointed about the problems you're facing and feel grateful for the things that are going well at the same time. In fact, positive feelings like thankfulness can help you deal better with the inevitable negative ones.

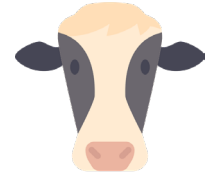
Practicing gratitude may seem elementary, but it is extremely powerful and effective and simple everyday practices can help overcome any obstacles in your way.

Quota Exchange

The market-clearing price established for the September 2022 Quota Exchange was \$43,100.00.

The next Quota Exchange will be held on October 15, 2022. All offers to sell and bids to purchase quota through the Quota Exchange must be submitted by midnight, October 6, 2022. SaskMilk recommends that offers and bids be submitted well in advance of the deadline date to ensure adequate time for corrections, if necessary.

When making bids on the Quota Exchange, the price on offers to sell quota is the minimum price that the producer is prepared to accept for that quota. Only if the market-clearing price is equal to or greater than the producer's minimum price will that producer qualify for participation in the Exchange. Conversely, the price on offers to purchase quota is the maximum price that the producer is prepared to pay for that quota. Only if the market-clearing price is equal to or less than the producer's maximum price will that producer qualify for participation in the Exchange. The clearing price is set at the price where the smallest difference exists between the accumulated volume offered for sale and the accumulated volume bid to purchase. The results of the Quota Exchange are outlined in the following table.

WestGen Education Award

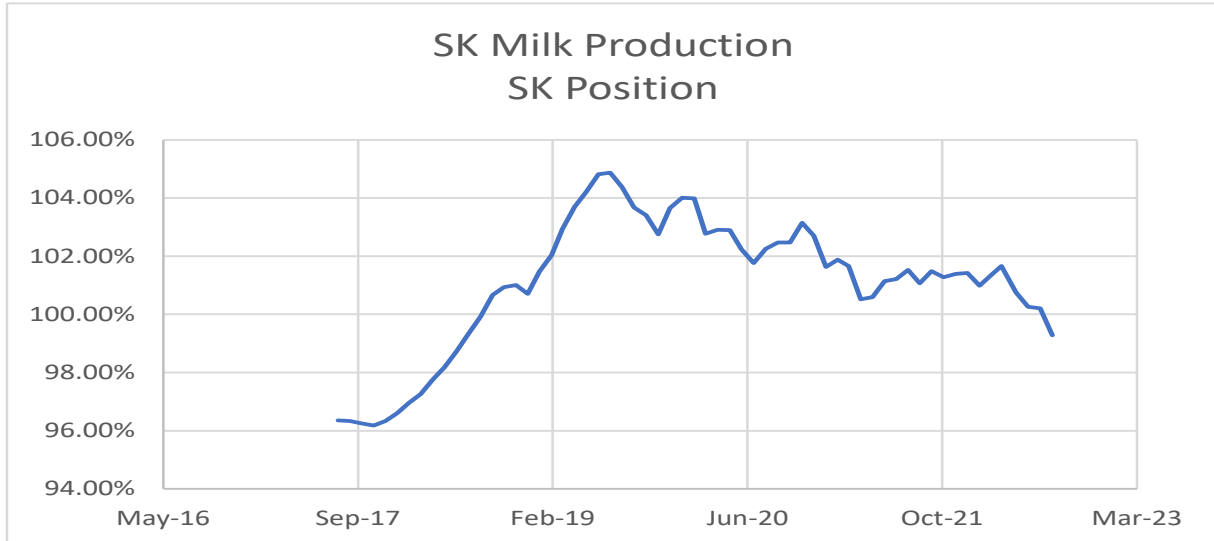

In August, Saskatchewan had a monthly CDC allocation of **1,064,115 kilograms** of butterfat. Saskatchewan production was **-56,497** of butterfat under and cumulatively over by **964,014 kgs** of butterfat. On a percentage basis, Saskatchewan is **7.82%** above our CDC allocation flexibility limits based on the Continuous Quota model. The -2.00% lower flexibility limit is in effect.

proAction® Validation Services Transition to Lactanet

Starting October 1, 2022, Lactanet will be managing all proAction Validation services (on-farm validations and self declarations) across the Western Provinces. Lactanet has committed to having experienced validators within each province.

Frequently Asked Questions (FAQs)

What if my full validation is completed or my self-declaration is due before October 1, 2022?

SaskMilk's proAction Coordinator, Tina Leverton, will continue to be responsible for following up and approving all full validation and self-declarations for activities completed on or before September 30, 2022.

What validation services are Lactanet managing?

Lactanet will be responsible for contracting validators, including hiring, training and day-to-day management of validation processes and services.

What role will SaskMilk still have in proAction?

SaskMilk will be responsible for:

Training new farmers on the program

Training farmers on new and updated module requirements

Reminding farmers of their upcoming proAction activity

Assisting farmers with understanding and meeting program requirements

Compliance and Penalties

Participating in national discussions on program implementation and development

Who will be resolving my validation Corrective Action Requests (CARs)?

The Lactanet validator who completes the validation on your farm will be the person doing the follow-up with you. They will outline what documentation is required and indicate what the timeline is for providing that documentation to them. Once received and deemed completed, the validator will resolve/close the CARs in the National Electronic Administrative System (NEAS).

Who will be approving my validation?

Lactanet has a proAction Coordinator team leader, Kathryn Roxburgh, who will be responsible for the official approval of your validation in NEAS.

Who do I send my self-declaration to?

Farmers must complete their self-declaration through the NEAS system.

Who is approving my self-declaration?

Lactanet's second proAction Coordinator, Michela Arbuthnott, is responsible for approving and following up on all self-declarations submitted in NEAS.

How do I gain access to my NEAS account?

Contact SaskMilk's Coordinator, Tina Leverton, to receive account login information.

The NEAS account is used to complete the Environmental Questionnaire, SOPs, Self Declarations and is where your cattle assessment reports and previous validation reports are saved.

Who will be managing the compliance/withdrawal process?

Lactanet will advise SaskMilk of any farmers who have not met their proAction deadlines and SaskMilk will then initiate the compliance process and all respective activities thereafter. Withdrawal letters, penalties and CAR follow-ups will be administered and managed by SaskMilk's proAction Coordinator.

Will my validator change?

It is a possibility that for scheduling purposes and efficiencies, the validator completing your full validation may change from year to year.
