Changes to Milk Quality Progressive Penalties WMP Harmonized Policy Coming May 1st

A Western Milk Pool (WMP) harmonized version of the Progressive Penalty Policy (PPP) will be implemented across Manitoba, Saskatchewan, Alberta, and British Columbia. This new PPP will begin to roll out across the WMP in early 2023 in Manitoba and Alberta. Due to legislative complexities, British Columbia will follow several months later.

In Saskatchewan, the policy will take effect May 1, 2023, as the changes will be placed into Board Order. This harmonized policy includes changing the penalty amount, reducing the contravention period, and adding potential production licence suspension.

proAction[®] Validation: Lactanet and WMP Transition

The Western Milk Pool (WMP) partners responsible for proAction (BC Dairy Association, Alberta Milk, SaskMilk and Dairy Farmers of Manitoba) transitioned proAction validation and validator services to Lactanet back on October 1, 2022. The move to engage Lactanet as a third-party organization is expected to provide greater consistency of validation, rigour and assurance across all 1,400 dairy farms in western Canada. Since proAction is a Dairy Farmers of Canada national program, all proAction validators will continue to be trained and certified by them.

Lactanet already has experience in providing these validation services in Ontario. With Lactanet now taking on this role in the west, it will allow the WMP provincial producer organizations time to focus on providing assistance and education to dairy producers regarding best practices and advancements in dairy farming. Additionally, the WMP partners collectively have a greater capacity to recommend policy improvements to the proAction program and engage actively with key stakeholders, including dairy processors.

With four months of transition behind us, we continue to work together to streamline provincial processes and procedures, and to manage identified gaps. Communication amongst the WMP provincial partners and Lactanet staff occurs regularly, ensuring that services at the farm level continue with the fewest disruptions possible. In addition, we are pleased to note that all validators contracted by the WMP partners prior to October 1 have made the transition over to Lactanet and continue to validate in their respective provinces.

Through this WMP proAction validation services transition, a key area that has been highlighted is the opportunity to streamline provincial proAction procedures. There are several differences in how the individual provinces manage their respective administrative processes, including compliance policies. As the WMP transformation continues forward, these areas of the proAction program are prime examples of where the provinces will work together to harmonize all current policies, procedures, and programs to achieve a single WMP approach and delivery of proAction.

5 New Year's Resolutions For Better Mental

Do you have a New Year's resolution for the farm? Some of the resolutions could include managing costs better, focusing on a succession plan, and improving production practices. Another resolution to consider is focusing on your mental health, because taking care of you and your mental health is also taking care of the farm.

After another unprecedented year, many are looking to protect and make their mental health a priority. The past two years have been full of adjustments. And while we're looking forward to a brighter 2022, continuing COVID-19-related worries can make traditional New Year's resolutions stressful to stick to. Instead, make 2022 the year of mental health for you and your farm. This gentler approach can give you the space and time to think about what you want to change to feel better and what you realistically can do to achieve that change. By taking smaller, more achievable steps towards your goals, there is a greater chance that you will keep them.

This applies to all kinds of resolutions, including mental health. You can help manage your mental health symptoms by taking small steps every day. Of course, there's no one-size-fits-all approach to mental health. But these simple, low-stress resolutions can help boost your mental wellness for a happier New Year.

- 1. Make time for self-care: Self-care is something that can be done in as little as 10 minutes a day with no cost at all. And it can help reduce stress and positively impact your mental health and well-being. Brainstorm a list of self-care activities that make you happy and schedule them as part of your daily routine. - 4. Reduce time spent on social media: Studies have shown that an excessive use of social media can lead to less moment-to-moment happiness and less life satisfaction. Quota Exchange


The market-clearing price established for the January 2023 Quota Exchange was \$39,050.00.

The next Quota Exchange will be held on February 15, 2023. All offers to sell and bids to purchase quota through the Quota Exchange must be submitted by midnight, February 6, 2023. SaskMilk recommends that offers and bids be submitted well in advance of the deadline date to ensure adequate time for corections, if necessary.

When making bids on the Quota Exchange, the price on offers to sell quota is the minimum price that the producer is prepared to accept for that quota. Only if the market-clearing price is equal to or greater than the producer's minimum price will that producer qualify for participation in the Exchange. Conversely, the price on offers to purchase quota is the maximum price that the producer is prepared to pay for that quota. Only if the market-clearing price is equal to or less than the producer's maximum price will that producer qualify for participation in the Exchange. The clearing price is set at the price where the smallest difference exists between the accumulated volume offered for sale and the accumulated volume bid to purchase. The results of the Quota Exchange are outlined in the following table.

In December, Saskatchewan had a monthly CDC allocation of **1,164,972 kilograms** of butterfat. Saskatchewan production was **-86,607** of butterfat under and cumulatively over by **885,310 kgs** of butterfat. On a percentage basis, Saskatchewan is **7.13%** above our CDC allocation flexibility limits based on the Continuous Quota model. The -2.00% lower flexibility limit is in effect.

DFC Update

proAction's Animal Care framework consistent with national standards, says NFACC

An independent review by a credible third-party organization has reaffirmed that the proAction Animal Care module developed by Dairy Farmers of Canada (DFC) and implemented on Canadian dairy farms is consistent with national animal care standards.

In a letter to DFC this November, the National Farm Animal Care Council confirmed it has independently reviewed the content of the DFC's proAction® program and found it to meet all requirements of Canada's Animal Care Assessment Framework. This national framework was developed by consensus among multiple stakeholders and

sets a credible process for developing animal care assessment programs.

"This declaration from NFACC serves as further recognition that the best management practices followed by Canadian dairy farmers under the pro-Action program are consistent with the highest standards of animal care," says DFC President Pierre Lampron. "Under proAction, Canadian dairy farmers produce high-quality, nutritious milk in accordance with some of the world's most stringent standards. proAction builds on robust federal and provincial regulations, instilling confidence that every drop of Canadian milk was produced with care."



The Animal Care module of proAction is based on the Code of Practice for the Care and Handling of Dairy Cattle, which is a science-based, nationally developed guideline containing both requirements and best practices for dairy cattle care and handling.

DFC recently issued its 2022 Progress Report on proAction, highlighting progress made by the dairy sector over the past year in the program's six priority areas: milk quality, food safety, animal care, livestock traceability, biosecurity and the environment. It also draws links between proAction and DFC's Net-Zero Strategy.






