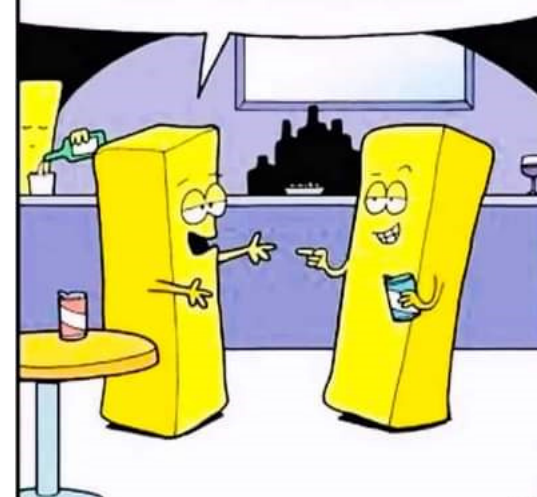
Dairy Direct Payment Program

The Dairy Direct Payment Program (DDPP) letters have been mailed to producers. Please follow the instructions on your letter to register for your payment. This round of payments provides dairy producers in Canada with compensation for the Canada-United States-Mexico (CUSMA) agreement and amount to \$300 million for 2023-2024. Cleanfarms Survey

Your feedback is required – Earn \$30 to complete an online survey about agricultural plastics management

An important ag plastics management survey is underway in Saskatchewan, which includes a survey of Saskatchewan dairy farmers.

The survey will help the industry understand current behaviours and attitudes farmers have toward agricultural plastic and measure participation in pilots and potential projects.

The survey is being conducted on behalf of Cleanfarms – a non-profit industry stewardship organization that manages programs that collect non-organic farm waste, mainly ag plastics, for recycling and safe disposal.

SaskMilk encourages you to participate to ensure our members' voices are represented.

The survey will take about 20 to 25 minutes to complete. To qualify for this survey, you must be one of the main decision makers regarding what to do with ag plastics, once used. For those who qualify (based on a few short questions at the start) and complete the survey, an honorarium of \$30 will be provided. Please note that once the targeted sample size has been reached, the survey will be closed and no further responses will be accepted.

Your responses will be held in complete confidence by Stratus Ag Research and used only for research purposes. Results will be grouped for analysis, and no identifying information will be attached to any responses.

Mental Health Spotlight



The Power of Physical Activity on Mental Health

In today's fast-paced world, prioritizing mental health is more important than ever. While seeking therapy, practicing mindfulness, and connecting with loved ones are all valuable tools, we often overlook the immense benefits that physical activity can bring. Engaging in regular exercise not only enhances our physical well-being but also has a profound impact on our mental health.

- 1. Reduces Stress and Anxiety:** Physical activity serves as a powerful stress reliever, helping to manage and alleviate symptoms of anxiety. Exercise stimulates the production of endorphins, often referred to as "feel-good" hormones, which promote a sense of wellbeing and act as natural mood boosters. A study published in the *Journal of Sport and Exercise Psychology* found that individuals who engaged in regular exercise experienced lower levels of anxiety and reported better stress-coping mechanisms (1).
- 2. Enhances Mood and Reduces Depression:** Regular exercise has shown promising results in combating depression and improving overall mood. Physical activity increases the release of neurotransmitters such as serotonin, which plays a vital role in regulating mood. According to a meta-analysis published in *JAMA Psychiatry*, exercise was found to be equally effective as other standard treatments for depression, demonstrating its potential as an adjunct therapy (2).
- 3. Boosts Cognitive Function and Memory:** Engaging in physical activity has been linked to improved cognitive function, including enhanced memory, attention, and decision-making abilities. Exercise promotes the growth of new neurons and increases blood flow to the brain, contributing to better overall cognitive performance. A study published in the *Journal of Aging and Physical Activity* found that regular aerobic exercise positively influenced memory and cognitive flexibility in older adults (3).
- 4. Increases Self-Esteem and Body Image:** Participating in physical activity can positively impact self-esteem and body image. Regular exercise helps individuals feel more confident and comfortable in their bodies by promoting a sense of achievement, improved physical fitness, and body strength. A study published in the *Psychology of Sport and Exercise* showed that exercise interventions significantly improved self-esteem and body image perception in both men and women (4).
- 5. Promotes Better Sleep:** Quality sleep is crucial for maintaining good mental health, and physical activity plays a key role in promoting restful sleep patterns. Engaging in regular exercise can help regulate sleep-wake cycles and reduce insomnia symptoms. A study published in *Mental Health and Physical Activity* found that individuals who met the recommended physical activity guidelines experienced better sleep quality and duration (5).

The Do More Agriculture Foundation is the national voice and champion for mental health in Canadian agriculture and is changing the culture of agriculture to one where all producers are encouraged, supported, and empowered to take care of their mental wellbeing. Producers are among the most vulnerable when it comes to mental health issues. By collaborating with the entire industry and those working to address the state of mental health in Agriculture, we can and will make a substantial impact.

Apply for the Agriculture Student Scholarship

Do you know a student thinking about studying agriculture at a post-secondary institution in the fall of 2024?

For students passionate about telling the story of agriculture, the Saskatchewan Ministry of Agriculture is proudly offering the Agriculture Student Scholarship for the fourteenth consecutive year. This year, the scholarship amounts available have been increased.

Saskatchewan Grade 12 students and recent high school/GED graduates (within the last two years) have the chance to win a grand-prize scholarship of \$6,000 or one of three runner-up scholarships of \$3,000, when they submit a three-minute video or 1,000-word essay on farming and environmental sustainability. This year's scholarship theme encourages young people to explore the idea of environmental sustainability within farming and the importance of public perception on modern farming practices. Submissions should focus on progressive environmental practices conducted by producers and the importance of relaying messages to the public to enhance trust in the industry.

To be eligible for this scholarship, applicants must be planning to take an agriculture-related post-secondary education program beginning in the fall of 2024. This program is designed to help us identify and develop young agricultural leaders in the industry.

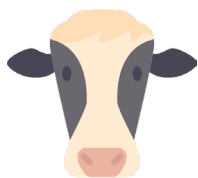

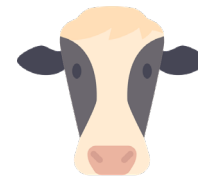

Quota Exchange

The market-clearing price established for the November 2023 Quota Exchange was \$38,000.00.

The next Quota Exchange will be held on **December 15, 2023**. All offers to sell and bids to purchase quota through the Quota Exchange must be submitted by midnight, **December 6, 2023**. SaskMilk recommends that offers and bids be submitted well in advance of the deadline date to ensure adequate time for corrections, if necessary.

When making bids on the Quota Exchange, the price on offers to sell quota is the minimum price that the producer is prepared to accept for that quota. Only if the market-clearing price is equal to or greater than the producer's minimum price will that producer qualify for participation in the Exchange. Conversely, the price on offers to purchase quota is the maximum price that the producer is prepared to pay for that quota. Only if the market-clearing price is equal to or less than the producer's maximum price will that producer qualify for participation in the Exchange. The clearing price is set at the price where the smallest difference exists between the accumulated volume offered for sale and the accumulated volume bid to purchase. The results of the Quota Exchange are outlined in the following table.

DFC Update

Now available: the fifth payment under the Dairy Direct Payment Program

Programs essential to our industry in the wake of the Canada-United States-Mexico Agreement (CUSMA) have recently opened.

Agriculture and Agri-Food Canada (AAFC) recently announced the availability of the fifth payment under the Dairy Direct Payment Program. A firm request by Dairy Farmers of Canada (DFC) to account for the impacts of CUSMA, the program will make available \$1.2 billion over six years. Qualifying dairy producers will receive payments based on their milk quota, and letters have been sent to them with instructions on registration. The deadline is March 31, 2024.

The Dairy Innovation and Investment Fund to help with solids non-fat surplus

The surplus of solids non-fat (SNF) in the dairy value chain has outpaced the industry's processing capacity. The Dairy Innovation and Investment Fund (DIIF) was supported by DFC to help our industry across the supply chain keep up with the growing demand for butterfat products such as cream and butter.

The Federal government is promising up to \$333 million over 10 years to help medium to large-scale projects modernize, replace, and/or increase processing capacity. The Canadian Dairy Commission will deliver funding from the DIIF on behalf of AAFC.

In October, Saskatchewan had a monthly CDC allocation of **1,214,170 kilograms** of butterfat. Saskatchewan production was **140,293** of butterfat under and cumulatively over by **973,692 kgs** of butterfat. On a percentage basis, Saskatchewan is **7.78%** above our CDC allocation flexibility limits based on the Continuous Quota model. The -2.00% lower flexibility limit is in effect.
